

## TYPES OF DOCUMENTS CONFIRMING FOREIGN LANGUAGE PROFICIENCY AT A LEVEL NOT LOWER THAN B2

Documents confirming proficiency in a foreign language at a level not lower than B2 include:

**1.** a certificate, diploma, or another document confirming knowledge of a given foreign language in the scope of four language skills: listening comprehension, reading, speaking, and writing, at the **B2**, **C1**, or **C2** proficiency level, issued by a designated institution:

a. in the case of the **English language**:

- University of **Cambridge**, **ESOL** Examinations:
  - B2 First (FCE),
  - C1 Advanced (CAE),
  - C2 Proficiency (CPE),
  - B2 Business Vantage (BEC Vantage),
  - C1 Business Higher,
  - Certificate in English for International Business and Trade (CEIBT),
- University of **Cambridge**, ESOL Examinations, **British Council**, IDP **IELTS** Australia: International English Language Testing System (**IELTS**) - minimum score of **5.5**,
- Trinity College London:
  - ESOL Skills for Life - Level 1 (B2) or higher,
  - Integrated Skills in English (ISE) - ISE II or higher,
  - ISE Digital - above 80 points (B2),
- Educational Testing Service (**ETS**):
  - Test of English as a Foreign Language (**TOEFL**), Internet-Based Test (**iBT**) - minimum **score of 72**,
  - Test of English for International Communication (**TOEIC**) - minimum:  
785 points in Listening & Reading,  
150 points in Speaking,  
160 points in Writing,
- **Pearson** Assessment English:

- Pearson English International Certificate - paper-based and computer-based versions (formerly Pearson Test of English General (PTE) or London Tests of English) - Level 3 (Edexcel Certificate in ESOL International Level 1 - grade: Pass, Merit, or Distinction) or higher,
- Pearson Test of English Academic (PTE Academic) - test-center and online versions - minimum **score of 59**,
- **LanguageCert** (PeopleCert Qualifications (PCQ)):
  - LanguageCert International ESOL - LanguageCert Level 1 Certificate in ESOL International (Listening, Reading, Writing) (Communicator B2), also issued under the name: LanguageCert International **ESOL** Communicator B2 Listening, Reading, Writing or higher, together with LanguageCert Level 1 Certificate in ESOL International (Speaking) (Communicator B2), also issued under the name: LanguageCert International ESOL Communicator B2 Speaking or higher,
  - LanguageCert Academic - LanguageCert Level 1 Certificate in ESOL International (Listening, Reading, Writing, Speaking) (LanguageCert Academic B2) or higher,
  - LanguageCert Test of English - LanguageCert Level 1 Certificate in ESOL International (Listening, Reading, Writing, Speaking) (LanguageCert Test of English B2) or higher,
- Education Development International (**EDI**), London Chamber of Commerce and Industry Examinations Board (**LCCI**):
  - English for Business Level 2 or higher,
  - Foundation Certificate for Teachers of Business English (**FTBE**),

  - Level B2 (Vantage) or higher,

**2.** A certificate confirming completion of a **preparatory course** for university studies (as defined in Article 60(4) of the Act of 12 December 2013 on Foreigners), lasting at least **9 months**, confirming proficiency in the foreign language in all four skills: listening, reading, speaking, and writing, at B2, C1, or C2 level;

**3.** A diploma of completed bachelor's, master's, or long-cycle master's studies in **philology** of the relevant foreign language or in applied linguistics, issued by a Polish or foreign higher education institution, together with a diploma supplement or official confirmation showing that the number of instructional hours in the foreign language was at least 500;

**4.** A diploma of completed bachelor's, master's, or long-cycle master's studies issued by a Polish or foreign higher education institution, indicating the language of instruction. If the language of instruction is not stated on the diploma, a diploma supplement or official certificate confirming the language of instruction must be provided;

**5.** An **International Baccalaureate Diploma** - for the primary language;

**6.** A **European Baccalaureate Diploma** - for the first (L1) or second (L2) language;

**7.** A certificate granting the right to work as a **sworn translator** of the given foreign language, issued by the Minister of Justice, as referred to in Article 5(2) of the Act of 25 November 2004 on the Profession of Sworn Translator, or an official confirmation of entry on the list of sworn translators.
